## NORA CECILIA ARISTIZÁBAL LÓPEZ

Nora graduated in Architecture from the *Universidad Pontificia Bolivariana*, and she has a Master's Degree in Urban Design from the Massachusetts Institute of Technology (MIT). In addition, she completed several specialized studies in Design Management, Land Management in Large Urban Projects, and Skills and Leadership Development.
